

Message from the Chair

A record number of former youth in care are pursuing post-secondary education as mature students with support from **United Way BC's Youth Futures Education Fund**. Between 2023 and 2024, the number of students over the age of 25 on tuition waiver and seeking support for basic living expenses, grew a record 18.5%.

While an expanded Provincial Tuition Waiver for all ages makes education and training more accessible and affordable, many mature students have additional responsibilities, including working or caring for young families or grandchildren. They may also be driving long distances to get to class and their job, all of which makes it hard to concentrate on schooling.

Supporting and encouraging these individuals to access education means more knowledge, experience and perspective gets shared in a meaningful way with our communities and society. This year, the Youth Futures Education Fund provided almost \$700,000 in barrier-free funds, our highest disbursement to date, to former youth in care so they could study with greater peace of mind. More than half of those students qualify as mature.

Through the Youth Futures Education Fund, United Way BC is proud to be part of these students' journeys. But we couldn't have done it without the generous support of our many donors. All donations to the fund are directly invested in supporting students' success, but the need is still great. Thank you for helping to create a world where everyone has an equal opportunity to make a difference in the world through higher education, and for considering a future gift that will change lives.







Thriving thanks to Youth Futures Education Fund



Grandmother of 10 and Sixties Scoop survivor, RavenSong received her Associate Arts degree from Kwantlen Polytechnic University in June 2024 after 23 years of perseverance and hard work. She's part of an 18.5% spike in mature students seeking support from United Way BC's Youth Futures Education Fund for basic living expenses like rent, childcare, transportation, and emergencies.

In 2023, thanks in part to United Way BC's ongoing advocacy, the Government of British Columbia expanded the tuition waiver to all BC former youth in care (regardless of age) as part of StrongerBC's Future Ready plan to make education and training more accessible and affordable. Many individuals formerly in government care, like RavenSong, who did not have the opportunity to pursue education previously are now able to do so.

RavenSong was well on her way to getting her degree, but circumstances intervened. Government agencies threatened to take away her son who had special needs if she continued school, so she quit to take care of him and her oldest daughter. She went on to have two more youngsters and when she became an empty nester, she went back to school.

"It's a big deal to me, a big deal. And I couldn't have done it without [Youth Futures Education Fund's] help," says RavenSong. "It was just amazing that that's even a possibility. I thought I'd be denied because of my age, right? There was no ageism."

The challenges older adult students face is often different from those of younger students. They can be caring for young families or grandchildren, working, and driving long distances to get to class. All these factors make it hard to pursue higher education.

"Supporting former youth in care who are mature students is a way to strengthening communities. When people go back to school, they're not only enriching their own lives—they're inspiring others and bringing fresh skills and perspectives into our communities and the workforce," says Trisha Dulku, Strategic Initiatives Manager, Community Impact & Investment, United Way British Columbia.

RavenSong, who is from the Deh Gáh Got'¡e First Nation in the Northwest Territories, was part of the Sixties Scoop when over 125,000 First Nation, Métis, and Inuit children were removed from their homes, communities, and families of birth. Today, she is President of a non-profit society called the Sixty Scoop Indigenous Society of British Columbia and shares her experience nationally and internationally.

"We support 60 scoop survivors and both sides of their families both the white adopted side and the native biological side, because we're all one and I'm tired of the division," RavenSong says. "We support families to integrate both ways. We also support helping Indigenous people return to their families of origin and do the connection process as well."

Youth Futures Education Fund, United Way BC donors and others support bright futures for everyone, no matter what their age.



"Education and training are the best ticket to the middle class and to getting the skills people need to shape their lives. We expanded the Provincial Tuition Waiver Program to make this possible for the approximately 50,000 former youth in care in BC. United Way BC's Fund works with the Waiver Program to break down barriers and help people get the skills they need so they can live the lives they deserve."
